The EOCP Subsidy Program is funded by private donors and thus does not require copies of income statements or tax returns for application. However, the following documents ARE required before your application can be considered. Please review these carefully and contact us with any questions.

Please complete this form and forward the following to EOCP no later than August 31st, 2011 to be considered for a subsidized program spot for the 2011-12 year:

- Letter outlining the reasons why we should consider you for a subsidized program spot. Please be thorough and describe your situation and how you would benefit from financial support when sending your child to preschool. Please also indicate how easily you will be able to volunteer your time at the school.
- Pre-registration form for the preschool program plus the \$50 registration fee OR the Pathway to Preschool Program registration form with program fee balance (\$70). Cheques should be made out to East Oshawa Co-operative Preschool and dated for September 1st, 2011. If not selected for the subsidy, cheques will be returned by mail. For the Preschool Program, Ten additional post-dated cheques for \$80 each will be due at your family's orientation with the preschool teacher in September.

In addition to a family contribution towards the program cost for their child to attend, the following is also expected:

- \$50 registration fee (for Preschool Program only)
- Active fundraising with a minimum contribution of \$100 (profit raised) over the course of the year (Preschool Program only)
- A minimum of one duty day per month, scheduled in advance to assist the teachers around the classroom and/or to provide snack to the children
- Active involvement on at least one parent committee (ie: Equipment, Communications, Program Support, etc.)
- Attendance at the Parent Information Nights and Annual General Meeting

At this time it is the preschool's intention to offer the above programs for the 2011/12 school year. Programs offered may be subject to change depending on enrolment. If the program of your choice is cancelled due to enrolment, your program fee/registration fee will be returned to you. If no suitable subsidy applications are received, EOCP has the right to extend the application period at any time.

I hereby agree that I have reviewed this form and understand the expectations outlined for my family at the preschool. I recognize that failure to contribute to the preschool within the co-operative model may initiate a review of my eligibility for continued subsidy. EOCP has the right to discontinue subsidy support should the expectations outlined on this form not be carried out by the member family.
